The Fund aims to achieve long term capital growth by investing primarily in Canadian equity securities.


APPROACH

- Investments focused primarily in Canada.



Quarterly Fund Commentary

- The Fund's investments in, and underweight exposure to, materials and underweight exposure to financials detracted from relative performance.
- In materials, underweight exposure to Barrick Mining and investments in Franco-Nevada detracted from relative returns. In financials, investments in Onex and lack of exposure to a Canadian bank detracted from relative returns. In other sectors investments in Atkins Realis Group detracted from relative returns.
- The Fund's investments in consumer staples and investments in communication services contributed to relative performance.
- In consumer staples, investments in Saputo and out-of-benchmark exposure to Dollar Tree contributed to relative returns. In communication services, lack of exposure to a Canadian telecommunications company and investments in Alphabet contributed to relative returns. In other sectors, underweight exposure to Enbridge and investments in Toronto-Dominion Bank contributed to relative returns.

Annual Fund Commentary

- The Fund's investments in, and underweight exposure to, materials and investments in information technology detracted from relative performance.
- In materials, underweight exposure to Barrick Mining and lack of exposure to a gold producer detracted from relative returns. In information technology, underweight exposure to Celestica and investments in Lightspeed Commerce detracted from relative returns. In other sectors, investments in Alimentation Couche-Tard and TFI International detracted from relative returns.
- The Fund's investments in consumer discretionary and investments in communication services contributed to relative performance.
- In consumer discretionary, investments in Aritzia contributed to relative returns. In communication services, lack of exposure to a Canadian telecommunications company and investments in BCE contributed to relative returns. In other sectors, investments in Agnico Eagle Mines and Franco-Nevada contributed to relative returns.

Positioning and Outlook

- At the end of the quarter, the Fund had its largest overweight exposures to the consumer staples and industrials sectors. The financials and materials sectors accounted for the Fund's largest underweight exposures. In absolute terms, financials and materials accounted for the Fund's largest exposures, while health care and real estate accounted for the least absolute exposure.
- Canadian equities extended their advance through the fourth quarter of 2025, supported by a market that remained highly sensitive to incremental shifts in expectations for growth, policy, and the path of interest rates. Portfolio Manager Maxime Lemieux notes that investor positioning increasingly reflected a willingness to look through mixed economic signals, with risk appetite improving as incoming data aligned with expectations for easier financial conditions. While long-term yields have remained relatively firm, the prospect of modest rate relief and ongoing fiscal support has helped underpin sentiment, particularly in areas tied more directly to economic momentum.
- Within Canada, Max observes that market leadership continued to broaden beyond the largest index constituents, with renewed interest in select cyclical and smaller- and mid-sized businesses. This has coincided with improving tone in parts of the industrial economy, including early signs of stabilization in certain activity indicators, alongside evidence that corporate spending intentions remain intact in pockets of the market. He also notes that activity levels in certain areas have been influenced by evolving trade policy and tariff-related behavior, which has at times shaped ordering patterns and inventory decisions.
- Commodities remained an important influence on Canadian equity performance in the quarter. Max highlights that structurally driven initiatives to secure critical supply chains continue to support investment and activity across parts of the metals complex, even as the near-term path can be affected by policy uncertainty and the timing of orders. He also notes that precious metals have attracted significant investor attention, and that sharp, rapid price moves can at times reflect a more speculative tone. This environment reinforces the importance of maintaining disciplined exposure sizing and a focus on underlying business fundamentals.
- Energy was a more nuanced part of the backdrop in Q4. Max notes that global supply dynamics and geopolitical developments can create meaningful cross-currents for pricing and for longer-term investment decisions. He also points to the strategic implications of trade relationships and North American policy negotiations, including how future agreements could influence relative competitiveness and market access across the region. Given the number of moving parts, the portfolio remains focused on businesses with resilient economics across a range of price environments.
- From a portfolio standpoint, the strategy remained anchored in bottom-up security selection, with an emphasis on balance sheet strength, durable cash flows, and management teams executing against clear operating priorities. Max indicates that he has continued to trim positions where valuations appear to be discounting an unusually optimistic path, and to redeploy toward areas offering more attractive long-term risk-reward profiles.
- Looking ahead, Max's view is that the economic backdrop remains constructive enough to support earnings growth, though headline market returns may become more closely tied to fundamentals as valuations normalize. He continues to monitor the evolving policy environment, the trajectory of inflation and rates, and the potential for changes in trade dynamics to influence business confidence and consumer behavior. Overall, the fund remains focused on diversification, disciplined risk management, and identifying high-quality companies that can compound through a wide range of scenarios.



Investment Process

Sources of information and investment ideas

- Notes from Team Canada analysts, meetings with company management, conferences and third party research and publications

Investment style and portfolio construction

- Bottom-up, fundamental company analysis is the primary driver of portfolio construction
- Stock selection is driven by a growth at a reasonable price (GARP) approach, with an absolute return bias and strong focus on mitigating downside risk during periods of market weakness
- Looks for companies that are expanding margins and driving earnings-per-share growth, through prudent cost management and growing top line revenue
- Valuation analysis includes absolute versus relative to peers and industry, Price/Earnings, FCF yield, EV/Sales, PEG emphasis for faster growing industries such as technology or biotech, EV/EBITDA
- Highly values management quality and experience
- Looks for stocks that will outperform the market and peers over the next 12-18 months
- May invest in restructuring stories if valuations are sufficiently attractive and the outcome of restructuring has the potential to unlock significant value
- Insensitive to benchmark composition
- Sector weights result from bottom up stock selection, while industry selection is informed by both bottom-up and top down considerations
- Position size a function of conviction, may concentrate up to 5-7% of the portfolio in a single stock
- May hold core long-term positions in the portfolio and may trade around these opportunistically
- Buys/sells purely a function of relative valuation and company fundamentals
- May invest in non-Canadian stocks up to 30% but allocations to foreign stocks will typically average 10% or lower
- Will typically hold 3-5% in cash, however, in certain market conditions, may hold cash balances between 0-20%

Risk control

- Constantly searching for stocks offering the best risk/ reward profile (upside/downside potential)
- Thoroughness of analysis is the key risk control measure
- Manager runs diversified portfolio, typically less than 100 names, but willing to have significant under/overweights at stock or sector level
- Shifts portfolio beta based on market environment and whether market will pay for taking on a higher level of stock or portfolio risk
